SWEEPSTAKES PERIOD: The Sweepstakes begins at 12:01 AM US Pacific Time (“PT”) on October 5, 2025, and ends at 11:59 PM PT on December 20, 2025 (the “Sweepstakes Period”).

The computer clock of the Administrator is the official time-keeping device in the Sweepstakes. By participating, participants (“Participants”) agree to be bound by these Official Rules and the decisions of Chattem Inc. (the “Sponsor”), which are binding and final on matters relating to this Sweepstakes.

ELIGIBILITY: Sweepstakes is open only to legal residents of the fifty (50) United States and District of Columbia (NOT including residents of Puerto Rico or other U.S. Territories), who are at least eighteen (18) years of age or the age of majority in their state of primary residence (whichever is older) at time of Sweepstakes Entry. The Drawing is expressly void in Puerto Rico, Guam other U.S. territories and where otherwise prohibited by law. Employees, officers and representatives of the Sponsor, Southern Made Services, LLC (the “Administrator”), Fandango Loyalty Solutions, LLC (“Fandango”) and each of their respective parents, affiliates, subsidiaries and web-design, advertising, marketing, fulfillment, judging and promotion agencies, or other agency involved in the administration, development, fulfillment and execution of this Sweepstakes, and their immediate family members and household members, as each is defined below, are not eligible to participate in the Sweepstakes. “Immediate family members” shall mean parents, stepparents, children, stepchildren, siblings, stepsiblings, or spouses, and their respective spouses. “Household members” shall mean people who share the same residence at least three (3) months a year, whether or not related. See Appendix at end of these Official Rules for a list of all participating products. Visit www.activaterewards.com/heathyrewards (the “Website”), submit an image of your full receipt, or a screenshot of your shipping, pickup or delivery confirmation for online purchases, during the Sweepstakes Period for validation. Submissions are reviewed within 2-5 business days. Once your receipt has been validated, you will receive an email confirming your Sweepstakes Entry. For each validated receipt submission, you will receive one (1) Sweepstakes Entry (each, a “Purchase Entry”).

2) Alternate Means of Entry: To receive one (1) Sweepstakes Entry without making a purchase (“AMOE Entry”, together with Purchase Entries, “Sweepstakes Entries”), visit healthyrewards.entertowinprizes.com (the “AMOE Website”), and complete the online form to receive one Sweepstakes Entry.

Sweepstakes Entries generated by script, macro or other automated means, and Sweepstakes Entries by any means which subvert the entry process, are void. By submitting a Sweepstakes Entry, you agree to the Official Rules and are willing to provide your information to the Sponsor and the Administrator. No photocopied or mechanically reproduced Sweepstakes Entries accepted. Sweepstakes Entries become the property of the Sponsor and will not be returned.

None of the Released Parties (as defined below) are responsible for Sweepstakes Entries, Sweepstakes-related e-mail, Sweepstakes-related push notifications, claims or notices that are lost, late, illegible, misdirected, damaged, incomplete or incorrect.

SWEEPSTAKES PRIZE DRAWING & WINNER NOTIFICATION: Odds of winning will depend on the number of Sweepstakes Entries received during the Sweepstakes Period. Winner will be selected and notified on or around December 29, 2025. Winner will be randomly selected under the discretion of the Administrator (the "Drawing"). Winner will be contacted via email.

The potential Winner and Guest will be required to execute and return an affidavit of eligibility, a taxable income form, W9, a liability release and, where lawful, a publicity release within five (5) days of date of issuance of email notification of potential win. If such documents are not returned within the specified time period, prize notification is returned as undeliverable, the Sponsor or its agent is unable to contact a potential winner or a winner is not in compliance with these Official Rules, prize will be forfeited and, at the Sponsor's discretion, an alternate prize winner may be selected. The Sponsor reserves the right not to award a prize in the event the Sponsor is unable to identify and confirm a winner after attempting to contact alternate winners.

SWEEPSTAKES GRAND PRIZE (1): There is one (1) grand prize ("Prize") available to be awarded. Prize winner ("Winner") will receive an all-inclusive wellness getaway, consisting of a three (3) day, two (2) night trip for Winner and one (1) guest ("Guest") to Tucson, AZ. If terminated, at its discretion, the Sponsor reserves the right to select the potential Prize Winner from all eligible, non-suspect Prize claims received prior to action taken or as otherwise deemed fair and appropriate by the Sponsor. In no event will the Released Parties be liable for more than the stated number of Prizes in these Official Rules. Any controversy or claim arising out of or relating to these Official Rules, or the Sweepstakes shall be settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association.
